

It is informed that the Provisional Selection List of all verified candidates for the post of **SGT/LP** is hosted on [www.cse.ap.gov.in](http://www.cse.ap.gov.in) / [www.apdsc.cgg.gov.in](http://www.apdsc.cgg.gov.in).

The Provisional Selection List is subject to the following conditions:

1. The candidates are provisionally selected. Their selection is purely temporary and subject to the out come of the directions/judgments on various WPs/OAs filed before the Hon'ble High Court/ Tribunal from time to time.
2. If the certificates furnished by the candidates in respect of qualifications/ Date of Birth/Local area/Caste/ PHC etc., are found to be non-genuine, bogus and if it comes to the notice of the department, their selection shall be cancelled besides initiating criminal proceedings against the individual(s).
3. The Provisional Selection List now hosted is displayed in the order of Merit duly demarcating the category under which the candidate is Provisionally Selected.
4. The candidates who are under selection zone and whose certificates are not yet verified due to non receipt from the referred/ concerned hospitals and non producing of community certificates, such names are not displayed here. As and when, the verification details in respect of these candidates are received from the concerned, the same will be displayed.
5. All selected candidates should participate in the Web counselling provided separately and indicate their order or emergence against the vacancies displayed. If the selected candidates does not participate in Web counselling and does not submit his/ her online preference in time, it will be construed that he/she is not interested to accept the selection of his candidature. No further transaction in this regard will be entertained.
6. The appointment letters will be issued by the concerned departments (Municipal administration, School Education) to selected candidates.

It is further informed that any grievance with regard to display of Provisional Selection List, the Candidate should approach the District Selection Committee-2014 for redressal of the same.
